### “Riding As One” Clinic

This clinic focuses on the Tao of Horsemanship Approach to riding harmoniously with your horse. Specific riding exercises, and patterns, are designed daily to assist in developing the following within you and your horse: mind-body awareness, acquisition of an independent seat through balance and the understanding of your center of gravity, a deeper connection, softness within, more willingness to respond to your body, rein and leg aids, and the ultimate development of consensual partnership between horse and human.. *A great clinic for those seeking more mind-body connection, communication, balanced and centered riding, partnership and control with their horse!*

## **General Clinic Information**

### **Format**

Caroline Rider will be the instructor at each clinic. No more than 8 participants within each clinic with their horses. Rider Horsemanship will take the first 8 students that register and pay full payment. There will be a waiting list after the participant spots are booked. If there is a cancellation of one of the 8 participant spots we will contact the names on the waiting list. If you are contacted to fill a spot we will require a non-refundable full payment to confirm your participation in the clinic.

Caroline pays individual attention to each and every participant in her clinic. If an apprentice is available, they will accompany Caroline to all 2010 Horsemanship Clinics. This is to ensure that in addition to direct group and one-on-one instruction directly from Caroline, owners can always be assured of help when they need it most.

Clinics begin anytime between 8-9am and usually wrap up around 5pm, with a 1.5 hour lunch break. The actual progress depends on the participants and their horses. Caroline's ultimate goal is to help each participant:

1. Gain a better understanding of their horse through education & insights into equine behavior.
2. Incorporate that knowledge with newly acquired skill sets learned.
3. Create a more fulfilling and rewarding relationship with their horse.

### **Auditors**

The cost to observe is \$30.00 per day prepaid. Children 12 & under are free. Seating may be limited at select clinics. Please note - we may ask observers to bring lawn chairs at these clinics.

Observers are asked to reserve ALL questions for after the clinic. Training products, DVD's and clothing will be for sale at each clinic.

*Please note, the following are not allowed: video taping & pets.*

### **Deposits/Final Payments**

To confirm your participation full payment is due upon registration, with signed paperwork and forms. Please be sure you are willing to commit to attending the clinic as payment is NON REFUNDABLE.

### **Cancellation**

You are responsible for filling your spot should you cancel. Please check in with us should we have a wait list.

We reserve the right to cancel, and/or reschedule due to lack of registration or severe weather. Clinics are held rain or shine.

## **Clinic Rules and Policies**

By signing up to participate in, or audit, a Rider Horsemanship Clinic, I am stating that I have read, understand and agree to the following rules and policies:

1. Full payment & ALL forms are due 30 days PRIOR clinic participation.
2. Clinic openings are on a first come, first served basis. If the clinic is full, your name will be put on our wait list.
3. There is a charge for auditing and is subject to specific format.
4. Refunds for cancellations are as follows – full refund prior to 30 days before clinic with replacement from wait list; audit fees are non-refundable. Refunds will be processed immediately of refund criteria being met.
5. No stallions, no exceptions.
6. No “Green” horses: horses with less than 5 rides.
7. Kids under 12 years old receive free audit if accompanied by paying adult.
8. Mandatory: copy of current NEGATIVE coggins, and vet records (Rhino Flu Vaccination included). You will not be accepted otherwise.
9. \$35 fee for NSF checks.
10. All participants must sign a liability waiver.
